In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, owners of the premises upon which the event is being held and their employees, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the premises, grounds, or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for the loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence of any other person or any other cause or causes. Notice to Participants/General Information

Facilities: BIG SKY DOG CENTRE

- The trial will be held indoors, in a heated hall with turf flooring.
- **No outdoor shoes may be worn inside the hall.** Only a change of shoes or bare feet are permitted.
- This is a one-ring event.
- **No crating is available inside the hall.**
- Competitors are responsible for their own crating, seating, food & water.
- Self-serve coffee and tea will be available.
- There is no lunch provided, so please pack your own lunch. There is nowhere close by to buy lunches or snacks.
- Portapotty is available.

Dogs:

- All dogs must be kept in an x-pen, crate or on leash when not in the ring.
- Handlers are responsible to keep their dogs quiet at all times.
- Handlers are responsible to clean up after their dogs.
- Any dog engaging in aggressive behaviour at any time will be required to leave the trial grounds. There will be no refund of fees in such instances.
- Any handler displaying inhumane or aggressive treatment of any dog, physically or verbally, while on site, will be asked to leave the trial grounds. There will be no refund of fees in such instances.

Directions to Event Site: Big Sky Dog Centre, 445 Florida Rd, Harrowsmith, ON

Travelling from the West (Belleville to Kingston) - Via Hwy. 401 East:

- Take exit 599 for Wilton Road, Yarker.
- Turn left onto Wilton Road 6, heading north
- Continue for approximately 10 minutes
- Turn right onto Route 20, Wilton Road
- Turn right onto **Florida Road** and continue until **4445 Florida Road**

Travelling from the east (Brockville to Kingston) - Via Hwy. 401 West:

- Take exit 611 for County Road 38, Harrowsmith.
- Turn left onto Highway Road 38, heading north
- Continue for approximately 12 minutes
- Turn left onto Yarker Road
- Take the 1st left onto Henderson Road.
- Take the 1st left onto **Florida Road** and continue until **4445 Florida Road**
